AGENCY STATEMENT	Established pursuant to Title 41 of the Fixing America's Surface Transportation Act (FAST-41), 42 U.S.C. section 4370m <i>et seq.</i> , the Federal Permitting Improvement Steering Council is an independent Federal agency comprised of the Permitting Council Executive Director, who serves as the Council Chair, 13 Federal agency council members designated by the Secretaries of Agriculture, Army, Commerce, the Interior, Energy, Transportation, Defense, and Homeland Security, Administrators of the Environmental Protection Agency and the Department of Housing and Urban Development, and Chairmen of the Federal Energy Regulatory Commission, Nuclear Regulatory Commission, and the Advisory Council on Historic Preservation, and additional council members, the Chair of the Council on Environmental Quality and the Director of the Office of Management and Budget. FAST-41 establishes creates special procedures for Federal agencies to follow that are intended to facilitate deliberate, synchronized, and transparent Federal environmental review and decision making for FAST-41 "covered" infrastructure projects.
